Subject: Conducting of Limited Departmental Competitive Examination (LDCE)-2024 for the post of Assistant Superintendent in Pay Matrix Level 6 from Senior Passport Assistant in Pay Matrix Level 4 in Central Passport Organization (CPO).

The Ministry is in process of conducting a Limited Departmental Competitive Examination (LDCE) from the post of Senior Passport Assistant to Assistant Superintendent for the employees of CPO. The LDCE to be held for the year 2024 would be for 59 (UR-37, SC-15, ST-07) vacancies including 02 for PwBD (1-VH,1-HH). While the exact date of examination would be intimated later, the Centre of Exam would be Delhi only. The Centre for examination with its complete address would be mentioned on the admit card of the candidate.

2. **Eligibility:**

As per Recruitment Rules of Assistant Superintendent, a Senior Passport Assistant of the Central Passport Organization with five years of regular service in the grade and possessing a Bachelor's Degree from a recognized University or Association of Indian Universities / recognized degrees of foreign Universities is eligible to appear in the Limited Departmental Competitive Examination in the Grade of Assistant Superintendent.

3. The cut off date determining eligibility for the LDCE is the 1st day of April 2024 (01.04.2024) i.e. the year in which the examination is being held. Therefore, Senior Passport Assistants who have completed five years of regular service (and are graduate) as on 01.04.2024 are eligible to appear in the LDCE.

Note: The paper will consist of Objective Type-Multiple choice Questions only. The questions will be set both in English & Hindi for Part II, III, IV & V. Each Question shall carry four (4) marks. The minimum qualifying marks shall be 216 (i.e. 30%) for unreserved category and 180 (i.e. 25%) for SC and ST Categories, out of Maximum of 720 marks. There will be negative marking @25% for each wrong answer, thus 1 (One) mark Shall be deducted for each wrong answer.

5. The Syllabus for LDCE examination shall be as under:

Part-A: Computer Based (Multiple Choice Question) Examination carrying maximum of 720.

Part-I-General English: Question in this component will be designed to test the candidate's understanding and knowledge of English Language and will be based on spot the error, fill in the blanks, synonyms, antonyms, Spellings & detecting misspelled words, idioms & phrases, one word substitution, improvement of sentences, active & Passive voice of verbs, conversion into direct & Indirect narration, shuffling of sentence parts, shuffling of sentences in a passage, cloze passage & comprehension passage.

Part-II-General Studies: Questions in this component will be aimed at testing the candidates general awareness of the environment around him / her and its application to society. Questions will also be designed to test knowledge of current events and of such matters of every day observations and experience in their scientific aspect as may be expected of any educated person. The test will also include questions relating to India and its neighboring countries especially pertaining History, Culture, Geography, Economic Science, General Policy & Constitution of India, Current Affairs,

Part-III-Passport Act & Rules: Question will be based on rules regarding issue of Passports / Policy / Court Cases etc.

Part-IV- Service Rules & RTI Acts: Question will be based on Office Procedure, CCS (Conduct Rules) 1964, CCS (Leave) Rules 1972, TA Rules, CCS (Pension) Rules 1972, National Pension System. CCS (GPF) Rules 1960, FR-Part-I, Recruitment Rules, MACP Scheme, LTC Rules, Revised Pay Rules, 2016 & RTI ACT 2005 etc.

Part-V- Question will be based on GFRs-2017, Delegation of Financial Powers 1978, Latest Delegation of Financial Powers of Passport Officers, DDO Manual (issued by O/o Controller General of Accounts), Receipt & Payment Rules 1983 [Replaced in 2022 by Central Government Account (Receipts and Payments) Rules, 2022] (issued by O/o Controller General of Accounts).

Part-B: APARs of last 5 years shall also carry 80 marks @16 marks for each APAR. The Outstanding APAR shall carry 16 marks whereas Very Good, Good and Average APAR would carry 12, 08 and 0 (Zero) marks, respectively. This will be taken into account only for those candidates who qualify in the Computer Based examination i.e. candidates obtaining minimum 30% and 25% marks for unreserved and SC, ST Categories respectively. The marks of APAR will be added in total marks obtained in the examination and thereafter a merit list shall be prepared based on Computer Based Examination and marks obtained in APARs.

- 6. Since, the LDCE is optional, no TA / DA will be admissible for appearing in the Examination. Kindly inform all concerned officials in your office and circulate a copy of this amongst them.
